## What I Offer

- Commissioned original artwork (Paintings)
- Small original sketches
- Prints and reproductions of **my own original IP**
- Prints and reproductions of **licensed IPs where I have explicit permission**

## What I Don't Offer

- Prints or reproductions of IPs I do not own or have permission to use
- Unlicensed merchandise
- Print-on-demand services for third-party IPs
- Digital files for resale

## Pricing Guide (Paintings & Sketches)

Final prices depend on size, complexity, materials, and time required.

Prices may increase over time due to demand, availability, and material costs.

**Small Original Pencil Sketches - signed (A4 Sized) £200 – plus shipping**

**Small Original Paintings - signed (A4 Sized or Similar) £600 - plus shipping**

**Medium Original Paintings - signed (A3 Sized or Similar) £1200 - plus shipping**

**Large or Complex Paintings - signed (A2 Sized and Above - Price on Enquiry) £2000 & upwards plus shipping**

## How Sales & Payments Work

### Purchases via eBay

- Payment, checkout, and buyer protection are handled through eBay
- Pricing, shipping, and returns follow eBay's platform rules
- Any specific details will be communicated clearly within the listing or via eBay messages

### Direct Purchases & Commissions (Email / Social Media / Word of Mouth)

- Pricing and scope are discussed directly before work begins
- A 50% non-refundable deposit is required to secure the commission
- The remaining balance, plus shipping and insurance, is due upon completion and before dispatch

- Payment details will be agreed privately as part of the commission process

## **Terms & Conditions**

### **Payment**

- 50% non-refundable deposit required before work begins for direct commissions
- Balance due on completion, prior to shipping

### **Turnaround Times**

- Determined by size, complexity, and current workload
- Estimated timescales discussed and agreed in advance

### **Shipping & Insurance**

- Paid in full by the customer for direct commissions
- Added to the final balance
- Artwork securely packaged and insured for transit

### **Copyright & Reproduction Rights**

- Purchase includes ownership of the physical artwork only
- Copyright and reproduction rights remain with the artist unless agreed otherwise in writing
- Prints and reproductions may be produced where legally permitted (own IP or licensed IP only)
- No reproductions of unlicensed third-party IPs

I aim to keep the process friendly, clear, and enjoyable while ensuring my work remains sustainable and expectations are aligned on both sides.
